



MARITIME CENTRE'S RATES & FEES

Welcome to the Maritime Centre (MC)! We manage all property activities including storage, moorage, commercial leases, and requirements for DIY Customers and Contractors. Please contact Maritime Centre Management to complete necessary DIY/Contractor paperwork to get approval to work in the yard. The following activities are not allowed: sanding of antifouling, spray painting, grinding, or welding. All volatile products, including paint, must be purchased through the KKMI store.

Storage or moorage fees apply when less than 4 hours of KKMI labor per workday or 20 hours of work is requested each week. Storage fees apply when circumstances outside of MC or KKMI's control delay our ability to complete the work. After your project is complete, The Maritime Centre offers the next 3 days as free storage for you to pick up the boat, thereafter moorage or storage fees apply.

GUIDELINES

While visiting the facility, we require everyone to abide by the following guidelines for your safety, health, and to protect our environment. This includes the vessel owners, representatives, crew, and contractors.



BOATS

- Bring your own dock lines and shore power cord. When arriving, dock your vessel as far forward as possible to create space for other boats.
- Once a vessel enters our harbor it becomes under the jurisdiction of the MC and shall be berthed in its designated location only as directed. MC reserves the right to relocate vessels as needed.



PEOPLE

- When visiting during boatyard hours, Maritime Centre kindly asks that you do not interrupt KKMI Team members while they are working. If you need assistance, contact the KKMI office or your Project Manager.
- Staying aboard in the harbor or yard is permitted with prior approval; contact the MC for details.
- MC offers restrooms and shower facilities in our harbor, along with free Wi-Fi.
- Smoking is permitted ONLY in designated areas.
- Only KKMI Team members are allowed in workshops or other areas where restricted access signs are posted.
- Bare feet or any sort of open-toed shoes, such as flip-flops, are not acceptable footwear in an industrial environment.



CARS

- No vehicle may enter without prior authorization during regular yard production hours. Once authorized, load/unload and then immediately move your vehicle outside the yard. Only authorized vehicles may park within the yard during working hours AND only in a designated parking stall. Under no circumstances may a vehicle be parked adjacent to boat stands or block the fire lane.
- **Speed limit is 5 mph.**
- Vehicles entering the yard do so at the driver's risk. MC assumes no responsibility for any loss or damage that may occur.



PETS

MC allows pets on the premises - on leash. It is the sole responsibility of the pet owner to control and clean up after their pet. [See our pet policies.](#)



DIY & CONTRACTORS

Prior to working on any vessel, please contact Maritime Centre Management for mandatory insurance requirements and polices to work on the premises. Failure to do so will result in the revocation of privileges to work at our facility.
